**FEDERAL -- LONG TERM CARE INSURANCE**      The following information is provided from Sam Girson, NARFE NFVP, Region II

There will be an early LTC enrollment from March 25-May 15, 2002 and the regular Open season will start July 15-December 31, 2002. My suggestion to you, if you are

not fully knowledgeable about LTC, is to wait (unless there is a reason to sign up early) for the regular open season when educational material will be available. Also, more information will be published on LTC in forthcoming issues of "Retirement Life."

One word of caution! John Hancock and Metro Life are the authorized partners who are the official agents for the federal LTC insurance program. Make sure when you are talking with a John Hancock/Metro Life agent they are authorized to sell "federal" LTC insurance.
