**UNIFIED Dues:** The August/September issues of the "Retirement Life" magazine presented information governing the Single-Dues Referendum to determine whether a Nationwide Association Dues System is to be in effect as of April 1, 2000.

Each NARFE Chapter is required to conduct a vote in order to comply. For members of our Chapter, if the proposed uniform national dues structure is adopted, the total annual dues will rise to \$30: \$18 National; \$2 Federation; \$10 Chapter 740. At present your dues pays \$18 to the National Office NARFE and \$3 to Chapter 740. The Special Project Committee studied the proposed Single Dues Referendum. It reports as follows:

The major Chapter 740 expense is the Chapter Newsletter and Special Alerts to our members, which average six mailings a year. The costs of these mailings are approximately \$3 a year per member. Other incidental expenses come out of Chapter 740 Treasury Funds or are borne personally by Special Projects Committee members. The cost of the Chapter Web-site, which is one of best NARFE chapter web-sites in the country - was created and is maintained by Doug Crompton at no charge to the Chapter. **The Special Project Committee recommends that members vote to DISAPPROVE the Single \$30 Dues Referendum.**

If you wish to participate in the voting, please contact John DeMatteo (215-345-9033) prior to November 1, 1999. The votes will be tabulated to determine the number of Chapter 740 members voting to adopt or reject the proposed new dues structure.
